Our program options for residency teachers include a fast-track program to assist teachers who hold a Residency License in meeting NC DPI Licensure requirements.

Fully online program to maximize accessibility

All coursework is delivered 100% online to provide maximum flexibility and access for working residency teachers. No campus visits required.

Formal academic advising model

Candidates receive dedicated one-on-one support from an academic advisor. Advising includes personalized course registration, ongoing progress tracking, and proactive guidance to help ensure on-time program completion and licensure readiness.

Affordable tuition rates

Structured, career-focused plan of study

edTPA & Licensure Exam Support

Candidates receive structured edTPA preparation, with submission embedded in the final course of the program. Access to 240Tutoring is provided to support studying for licensure exams, ensuring candidates are well equipped for successful licensure-clearance.

University-Issued Certificate issued at completion (for certificate licensure areas)

Upon successful completion of program coursework requirements, candidates are awarded an official certificate from East Carolina University. This credential formally recognizes your achievement and can be added to your resume as verification of your professional preparation and commitment to education.

Cohort candidates must fulfill all requirements set forth by NC DPI Residency License requirements. This includes yearly licensure renewal, employment, testing, coursework, etc. Enrollment in ECU's program does not

guarantee employment or fulfillment of all licensure requirements. Information subject to change pending clarification from NC DPI. Please always consult with NC DPI & ECU websites regarding processes and deadlines.

RESIDENCY LICENSE OPTIONS STEPS FOR ACCEPTANCE

1. Determine if you are qualified to be hired as a Residency Candidate.

Review the Residency License Policy and requirements as listed on the NC DPI website.

- Content Proficiency (meet one or more areas)
- Institutionally accredited bachelor's degree
- 24 credit hours of coursework in the content area OR passing NCSBE exam score(s)
- Academic Proficiency
- 2.7 GPA (on a 4-point scale)

Former Lateral Entry candidates must have 24 hours and passing licensure exam(s).

2. Secure teaching position as a Residency Hire through NC DPI approved school or district.

Contact your desired school and/or approved charter school to confirm subject area eligibility, current vacancies, and processes for applying. You may be required to submit official transcripts or complete competency exam(s) prior to qualifying.

List of LEAs, Charter Schools, etc.

3. Connect with ECU Alternative Licensure to obtain required prior approval and confirm intent to enroll in ECU's program.

Affiliate with ECU as your approved Educator Preparation Program (EPP) by submitting an internal application, link found on website.

- Fall Cohort Application Window December 1 through June 15
- Spring Cohort Application Window July 1 through October 15
- Birth-Kindergarten (BK) application window and cycle is continuous

4. Secure institutional Admission

DO NOT apply to Admissions until receiving prior approval from the Office of Alternative Licensure.

Upon internal acceptance/prior approval from the Office of Alternative Licensure, secure institutional admission for the appropriate term and with the appropriate admissions link (provided by our office).

- Establish in-state status by connecting with <u>NC Residency Determination Service.</u>
- Activate ECU Student Email account

5. Connect with your ECU Educator Residency Model Advisor.

- Your advisor will assist you with registration each semester, as well as navigation of any institutional policies and procedures.
- Please send via email any passing NCSBE exam score(s) (required licensure area exams).
- Please send via email a completed RL form each year. This must be signed by your district licensure specialist.

RESIDENCY LICENSE PATHWAY OPTIONS

We offer two certificate options, as well as a non-certificate licensure option for specific licensure areas, designed to support current residency licensed educators on their path to clear licensure in North Carolina. Both programs are structured with the working professional in mind and meet the requirements for NC licensure. Compare your options below.

LICENSURE CLEARANCE REQUIREMENTS FOR ALL PROGRAM OPTIONS

1. Complete all coursework required of the program required GPA before the expiration of RL Year 3.

2. Pass licensure area exam(s) for residency licensure subject area(s).

3. Complete edTPA with a passing score.

The edTPA submission process is embedded within the Residency 2 Support course listed on the plan of study. Submission for scoring costs approximately \$300.

CERTIFICATE REQUIREMENTS

An application for graduation (issuance of the certificate) must be completed at least one semester prior to the completion of the requirements for the certificate. All certificate requirements must be completed before the first day of the subsequent term. **Certificate completers do not attend graduation ceremonies**.

Teacher Licensure Certificates at the Undergraduate Level To remain in good program standing, candidates must meet the minimum GPA

requirement of 2.7.

Teacher Licensure Certificates at the Graduate Level

To remain in good academic standing, candidates must meet the minimum GPA requirement of 3.0.

TUITION SNAPSHOT

East Carolina University offers **competitive distance education tuition rates** for working professionals pursuing residency licensure. Tuition rates vary depending on whether you enroll in the Undergraduate or Graduate certificate program.

Undergraduate Residency Certificate

Estimated total tuition cost - \$3,713.94 to \$4,332.93 (based on 18-21 credit hours) Estimated cost per course - **\$618.99** Credit hour rate - \$206.33 for a student that is classified as in-state

Graduate Residency Certificate

Estimated total tuition cost - \$5,487.12 to \$6,401.64 (based on 18-21 credit hours) Estimated cost per course - **\$914.52** Credit hour rate - \$304.84 for a student that is classified as in-state

Additional Costs

- Praxis or Pearson licensure exam(s)
- edTPA submission

Financial Aid

Because residency candidates are typically enrolled in **3 credit hours per term**, the program does **not meet the minimum enrollment required for federal financial aid**.

Tuition Payment Plan

ECU offers short-term **tuition payment plans** during the **Fall and Spring semesters** through the Cashier's office. These plans allow students to divide tuition into manageable monthly payments. Visit https://financialservices.ecu.edu for enrollment dates and terms.
